## MAIN OBJECTIVE

The AGRI - EW project's central objective is to enhance participatory procedures in the agricultural sector, which will result in sharing best transnational practices among social partners. The project's general objective is to facilitate workers' engagement in decision making to adapt to the new challenges brought by COVID-19 in the work organization via information, consultation and participation mechanisms and promote the implementation of the European Green Deal. Besides, the project aims to guarantee the better application of EU law (set of Directives) on employee participation in the agriculture sector. The project responds to the EC's action plan to support the full implementation of the European Pillar of Social Rights and make sure that no one is left behind in Europe's recovery after the COVID-19 crisis.

The action is promoted by a consortium consisting of organizations, workers' representatives, employers coming from 5 EU Member States (Italy, Poland, Spain, Slovenia, Romania) and two candidate countries (North Macedonia, Serbia).

- I.
